## **CONTINUED ORDER**

WHEREAS, recognition was granted to the institution namely, SHEETLA SHIKSHA MAHAVIDYALAYA, NEAR DAK BANGLA, GWALIOR ROAD, DABRA, GWALIOR MADHYA PRADESH under section 14(1) of the NCTE Act, 1993 for conducting B.ED. course of annual intake of 100 (two basic Units of 50 students each) vide order No.2-32/223176/70/2005/2768/dated 06.04.2005.with annual intake of 100

AND WHEREAS, the revised recognition order was issued to SHEETLA SHIKSHA MAHAVIDYALAYA, NEAR DAK BANGLA, GWALIOR ROAD, DABRA, GWALIOR MADHYA PRADESH vide order No. WRC/OAPW00634/223176 dated 31.05.2015 for B.Ed. Programme of two years duration with an annual intake of 200 students (two basic units of 50 students each) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided "..issued Show Cause Notice to the institution has not submitted compliance of the condition maintained in revise order"

AND WHEREAS, the Show Cause Notice was issued to the institution on 08.08.2016

AND WHEREAS, the matter was placed in 316<sup>th</sup> Meeting held on February 27-28, August & 04<sup>th</sup> September 2020 and the Committee decided that... "The WRC considered the entire issue in detail and noted that as per NCTE regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented premise with a condition to shift to their own premises within a period of three years from the date of such recognition.

the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

AND WHEREAS, Show Cause Notice was issued to the institution on 24.09.2020

and WRC decided.."The original file of the Institution along-with other related documents were carefully considered examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

- Recognition was granted to the institution on 06.04.2005 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
- 2. The institution has not shifted the institution in its own premises till date.
- Accordingly, Show Cause Notice was issued to the institution on 24.09.2020.
  The institution has not submitted the reply of the Show Cause Notice till date.
